## **How the Program Works**

The scholarship amount is \$1,250.00 for each year of the student’s attendance (approximately 1/3 of the annual tuition fees) for a total value of \$3,750. ## GSB ADMISSION REQUIREMENTS

Admission requirements are designed to select those who are prepared by experience and prior education to derive the greatest benefit from this advanced bank management program.

Qualifying criteria:

- Officers of banks or savings institutions with five years of banking experience, as well as a four-year college degree or four additional years of relevant experience.
- State and federal financial institution regulatory officials and bank directors with educational background and experience comparable to that required of bank officers.
- Non-officer bank or savings institution employees who are performing officer-level functions (letter of recommendation from chief executive officer required).
- Professionals from other financial service institutions and from firms providing services to banks with educational and experience backgrounds comparable to that required of bank officers.
